- 5) Complete, sign and return this contract with agreed deposit and acceptance of payment terms (100% is due after Dec. 15). Bride + Groom Publications LLC reserves the right to deny or adjust this contract.
- 6) Protect Bride List. The list of registered brides provided is for the exclusive use of Bridal Expo exhibitors ONLY. Exhibitor agrees not to lend-out, share, sell, barter nor allow any unauthorized usage, nor permit any reproduction thereof.
- 7) Follow Health Guidance Protocols as directed by Promoter, Venue, City or State (mask, social distancing etc)

It is further understood that the list of registered brides will be forfeited to exhibitors in violation of any part of the above listed (including complaints) and that additional action may occur (i.e. ban from future events, legal action).
